December 15, 2013- December 14, 2015

Every funeral director shall complete at least 15 hours of continuing education in each biennial renewal period.

Three hours are required in each of the four categories.

This is not a complete list of current approved continuing education courses and there is no guarantee that a course you want to take on this list is currently available. It is your responsibility as the licensee to verify that the continuing education courses you complete for your WI funeral director license are recognized under Wisconsin Administrative Code Ch FD 4 and to contact providers for program availability.

PLEASE NOTE: All courses that are APFSP-approved do not need a separate Department approval - Per FD 4.04 (8)
