

ESSENTIAL REFERENCES TO PASS THE STORAGE TANK PROGRAM COMM 10 & COMM 5 CERTIFICATION EXAMS

Note #1: Contractors performing the respective activities on field erected tanks under the supervision of a professional engineer are not required to maintain the respective Comm 5 credential.

Note #2: The aboveground installer exam covers all aboveground tank installation (i.e., heating fuel – NFPA 31, emergency generators – NFPA 37, etc.) to some degree.

Note #3: Individuals performing Comm 10 tank system tightness testing or corrosion protection testing must maintain a certification with the respective tightness testing/equipment methodology or professional corrosion protection organization (i.e., NACE, STI, etc.).
