- Where the Department of Natural Resources (DNR) has jurisdiction, a written approval may be required prior to installation of this product in a water supply system to reduce the concentration of a contaminant that exceeds the primary drinking water standards contained in ch. NR 809, Wis. Admin. Code, the enforcement standards contained in ch. NR 140, Wis. Admin. Code, or for a water supply system that is subject to a written advisory opinion by the DNR. Flow Rate: 7.6 liters per minute (lpm) [2.0 gallons per minute (gpm)]
Capacity: 7,571 liters (l) [2,000 gallons (gals.)] for free chlorine. For particulate reduction, dependent on the type and quantity of particulate matter present in the influent water; the need for maintenance may be indicated by a significant decrease in flow rate.

To qualify for free chlorine reduction, the device must reduce the influent challenge concentrations by ≥ 50%; meeting the free chlorine reduction requirements also qualifies the device for the reduction of aesthetic, organic, taste and odor reduction (e.g. geosmin, methylisoborneol); this does not include hydrogen sulfide. To qualify for particulate reduction (Class I), the device must reduce the influent challenge concentration by ≥ 85%.
