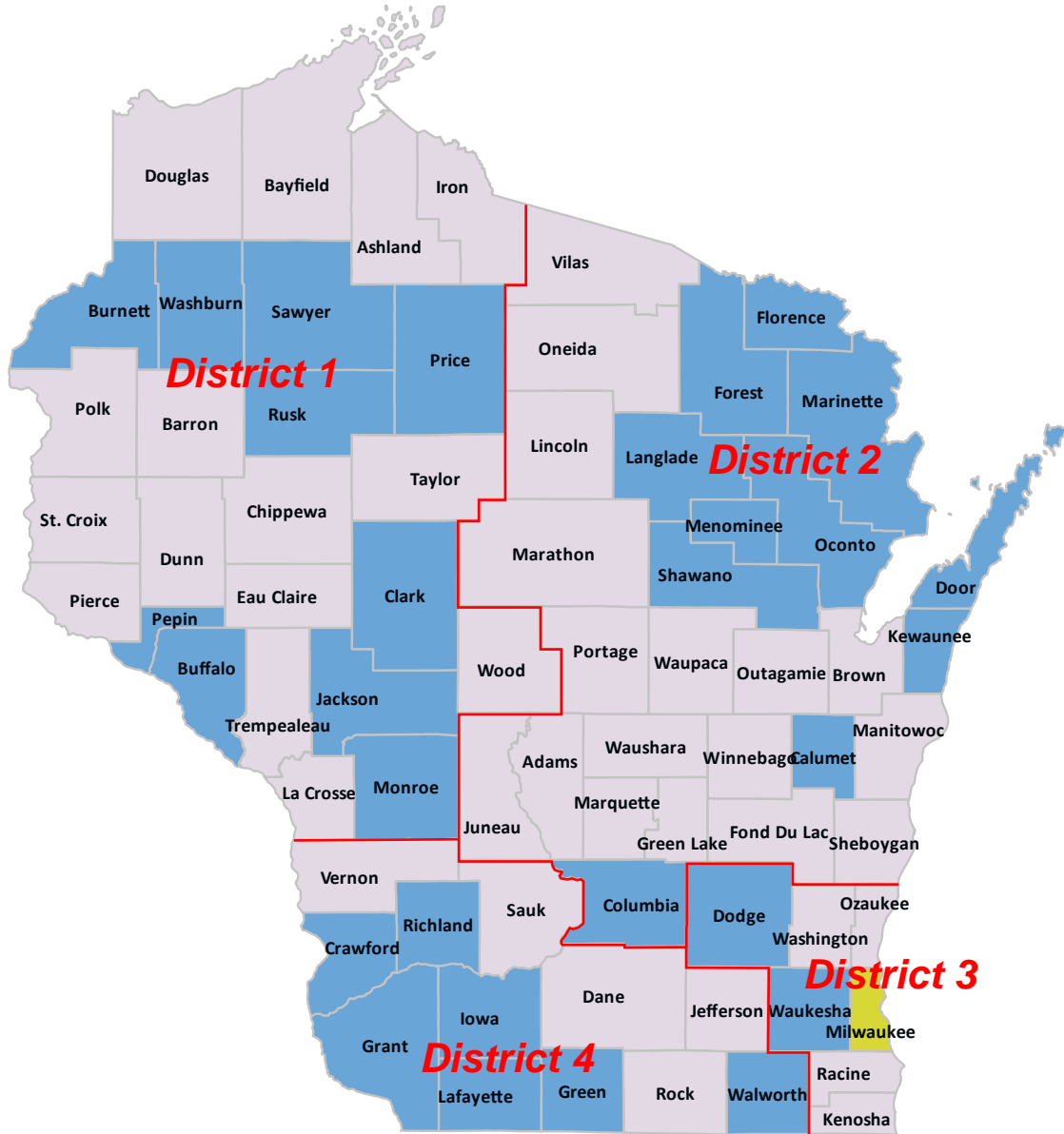




Body Art Agent District Map
