2023 SENATE BILL 143

March 23, 2023 - Introduced by Senators CABRAL-GUEVARA, ROYS and WANGGAARD, cosponsored by Representatives MAGNAFICI, DITTRICH, MURPHY and ROZAR. Referred to Committee on Health.

1 **AN ACT to create** 448.03 (3m) of the statutes; **relating to:** the use of certain
2 words and terms that refer to a physician.

Analysis by the Legislative Reference Bureau

This bill restricts the words and terms that may be used to designate certain medical professionals in titles, advertising, and descriptions of services. Under current law, no person may use or assume the title “doctor of medicine” or append to the person’s name the letters “M.D.” unless the person possesses the degree of doctor of medicine or the person is licensed as a physician by the Medical Examining Board. Similarly, only individuals who possess the degree of doctor of osteopathy may use or assume the title “doctor of osteopathy” or append “D.O.” to their name.

This bill restricts persons, except licensed physicians, from using certain words, terms, letters, or abbreviations that represent a person as a physician. Those restrictions under the bill apply to a person’s title, advertising, or description of services, and the bill provides an extensive but not exclusive list of the words and terms covered by the bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 **SECTION 1.** 448.03 (3m) of the statutes is created to read:
4 448.03 (**3m**) USE OF TERMS REPRESENTING PHYSICIANS. Except as otherwise
5 provided in this chapter, no person, except a licensed physician, may use or assume

1 the following words, letters, or terms in the person's title, advertising, or description
2 of services: "physician," "surgeon," "osteopathic physician," "osteopathic surgeon,"

5 "laryngologist," "nephrologist," "neurologist," "obstetrician," "oncologist,"

2023 SENATE BILL 158

April 3, 2023 - Introduced by Senators CABRAL-GUEVARA, COWLES, FELZKOWSKI, FEYEN, JACQUE, MARKLEIN and STROEBEL, cosponsored by Representatives GOEBEN, SORTWELL, ARMSTRONG, BEHNKE, BODDEN, BORN, DITTRICH, DONOVAN, GUSTAFSON, KITCHENS, KURTZ, MURPHY, MURSAU, O'CONNOR, OLDENBURG, PENTERMAN, ROZAR, SCHMIDT, SCHRAA, TITTL and WICHGERS. Referred to Committee on Licensing, Constitution and Federalism.

1 **AN ACT to amend** 440.08 (2) (a) (intro.) and 440.094 (1) (c) 3., 4. and 5.; and **to**
2 **create** 440.094 (1) (c) 9g., 9m., 17. and 19. and 440.095 of the statutes; **relating**
3 **to:** preliminary health care credentials granted to previously unlicensed
4 individuals.

Analysis by the Legislative Reference Bureau

This bill requires the Department of Safety and Professional Services to grant preliminary credentials to certain individuals who have recently completed the requirements to obtain a health care credential.

Under the bill, DSPS must grant a preliminary credential to an individual who attests to meeting all of the requirements for a corresponding permanent or training credential, including having completed all education, training, supervised experience, and similar requirements within the previous two-year period. The individual must also attest that he or she does not, to the best of his or her knowledge, have a disqualifying arrest or conviction record, and that he or she has been engaged by a health care employer to provide services that are within the scope of the credential that he or she is seeking. Finally, the individual must have also submitted an application for the permanent or training credential that remains pending.

The health care employer must submit to DSPS the employer's national provider identifier and attest to having engaged the individual to provide the aforementioned services. The health care employer must also attest that the individual has, to the best of the health care employer's knowledge and with a reasonable degree of certainty, completed the required education, training, and

supervised experience necessary for the corresponding permanent or training credential within the two years preceding the submission of the application for the preliminary credential, has passed required examinations, and has passed a background check performed by the health care employer.

The preliminary credential becomes effective upon the submission of the attestation by the health care employer or on a later date specified therein. The preliminary credential expires on the date that the application for the permanent or training credential is granted or denied. While providing services under a preliminary credential, the person is subject to all responsibilities and limitations of the corresponding permanent or training credential.

12 any of the health care providers enumerated in s. 440.094 (1) (c).

13 (d) “Services” means actions that are within the scope of practice that is defined
14 for a permanent health care credential or training health care credential.

15 (e) “Training health care credential” means a credential that authorizes an
16 individual to provide some or all of the services that may be provided under a
17 permanent health care credential while the individual works to satisfy further
18 education, training, supervised experience, and similar requirements that must be
19 satisfied in order to be granted a permanent health care credential.

20 **(2) PRACTICE BY PREVIOUSLY UNLICENSED INDIVIDUALS.** (a) Notwithstanding chs.
21 440 to 480, an individual may provide for a health care employer services that are
22 within the scope of practice that is defined for the permanent health care credential
23 or training health care credential described in subd. 1. g., and the department shall
24 grant the individual a preliminary health care credential under this section, if all of
25 the following apply:

1 1. The individual applies to the department for a preliminary health care
2 credential under this section. The individual shall include in the application an
3 attestation of all of the following:

4 a. The individual does not hold and has never held a license, certificate, permit,

7 b. The individual, within the 2-year period preceding the application under
8 subd. 1. g., completed all education, training, supervised experience, and similar
9 requirements that must be completed in order to be eligible for the permanent health

12 be eligible for the permanent health care credential or training health care credential
13 described in subd. 1. g., other than any interview or oral examination that may be
14 required for the permanent health care credential or training health care credential.

15 d. The individual does not, to the best of his or her knowledge, have an arrest
16 record or a conviction record, as those terms are defined in s. 111.32, on the basis of
17 which the department or credentialing board, as applicable, would deny the
18 individual's application under subd. 1. g. The department may, in the application for
19 a preliminary health care credential under this section, provide a space for the
20 individual to indicate if he or she has previously applied for a determination under
21 s. 111.335 (4) (f).

22 e. The individual, to the best of his or her knowledge, meets all of the
23 requirements, other than those specified in subd. 1. b. to d., for the permanent health
24 care credential or training health care credential described in subd. 1. g.

Analysis by the Legislative Reference Bureau

Under current law, it is a Class C felony for a person who is a licensee, employee, or nonclient resident of an entity that provides various welfare, foster, adoption, and health services, including a hospital, to have sexual contact or sexual intercourse with a client of the entity. Under some but not all circumstances, this prohibition applies to various health care providers and their clients. Under this bill, it is also a Class C felony for a health care provider to have sexual contact or sexual intercourse with a client.

Under current law, with some exceptions, a person is required to register as a sex offender for certain crimes that are sexually motivated. Under the bill, the new offense of sexual contact or sexual intercourse by a health care provider is subject to this provision.

Because this bill creates a new crime or revises a penalty for an existing crime, the Joint Review Committee on Criminal Penalties may be requested to prepare a report.

Analysis by the Legislative Reference Bureau

This bill creates a process for certain individuals who hold a license, certification, registration, or permit that was granted by another state to apply for and receive a reciprocal credential in this state. Under current law, an individual may not engage in certain professions or assume certain titles in this state unless the individual holds a credential issued by a department, examining board, or credentialing board with authority to oversee the profession or practice. Current law requires the Department of Safety and Professional Services, the Veterinary Examining Board, and any credentialing board attached to DSPS, with certain exceptions, to issue a reciprocal credential to a service member, former service member, or the spouse of a service member or former service member who resides in this state if certain conditions are met. This bill expands who may apply for reciprocal credentials to include all individuals. The bill does not allow individuals to receive a reciprocal credential from the Accounting Examining Board or the Real Estate Examining Board that would grant the holder of the credential a limited right to practice law in this state, unless the applicant is licensed to practice law in this state.



ANALYSIS

Statutes interpreted: Section 446.02 (2) (c), Stats.

Statutory authority: Sections 15.08 (5) (b) and 227.11 (2) (a), Stats.

Explanation of agency authority:

Section 15.08 (5) (b), Stats., provides that examining boards, such as the Chiropractic Examining Board, “[s]hall promulgate rules for its own guidance and for the guidance of the trade or profession to which it pertains . . .”

Section 227.11 (2) (a), Stats., sets forth the parameters of an agency’s rule-making authority, stating an agency “may promulgate rules interpreting provisions of any statute enforced or administered by the agency. . .but a rule is not valid if the rule exceeds the bounds of correct interpretation.”

Related statute or rule: None.

Plain language analysis:

The Board conducted an evaluation and update of ch. Chir 12 to ensure the definitions under s. Chir 12.01, the criteria for granting a certificate for nutritional counseling under s. Chir 12.02, and the criteria for approval of nutritional counseling educational programs under s. Chir 12.03 are consistent with current professional and academic practices and applicable Wisconsin statutes. As a result, the following updates have been made:

- A definition of “patient” is added to the definitions under s. Chir 12.01.
- The requirement under s. Chir 12.03 (2) (a) 5. that program subject matter is generally taught at the undergraduate or postgraduate level of a chiropractic college and relates to improving the clinical skills of a chiropractor is revised. The revised requirement is that program subject matter contributes to the advancement, extension, and enhancement of the clinical skills of a chiropractor and fosters the enhancement of general or specialized practice and values.
- Other provisions throughout ch. Chir 12 have been revised to provide clarity and conform to current drafting standards.

Summary of, and comparison with, existing or proposed federal regulation: None.

Comparison with rules in adjacent states:

Illinois: Illinois does not certify chiropractors in nutritional counseling. The statutory definition of chiropractic physician provides a chiropractor is not prohibited from providing advice regarding the use of non-prescription products (225 ILCS 60/2).

Iowa: Iowa does not certify chiropractors in nutritional counseling. Iowa statutes provide that licensed chiropractors who make dietetic or nutritional assessments or give dietetic or nutritional advice in the normal practice of their profession are exempted from the requirement to be licensed to practice dietetics (Iowa Code 2017, section 152A.3).

Michigan: Michigan does not certify chiropractors in nutritional counseling. By statutory definition, the practice of chiropractic includes the use of nutritional advice (MCL 333.16401).

Minnesota: Minnesota does not certify chiropractors in nutritional counseling. Minnesota statutes provide no person may engage in dietetics or nutrition practice unless the person is licensed as a dietitian or nutritionist (Minnesota Statutes 2016, section 148.630).

Summary of factual data and analytical methodologies:

The proposed rules were developed by reviewing the provisions of ch. Chir 12 to ensure the rules are consistent with current professional and academic practices and applicable Wisconsin statutes. No additional factual data or analytical methodologies were used to develop the proposed rules.

Analysis and supporting documents used to determine effect on small business or in preparation of economic impact analysis:

The proposed rules were posted for a period of 14 days to solicit public comment on economic impact, including how the proposed rules may affect businesses, local government units, and individuals. No comments were received.

Overview of Course Paradigm

All human cells receive their nutrition and have their waste removed by the fluid they are surrounded by. This fluid is called the **extracellular fluid** and must be maintained within relatively constant temperature, pH range, volume, and concentration of the dissolved particles within it.

The extracellular fluid is referred to as **the internal environment** and the processes used to maintain its constancy are collectively called the process of homeostasis.

The **hypothalamus** uses the **autonomic nervous system**, with its two divisions, sympathetic and parasympathetic, as well as the **endocrine system** to direct the body's ten organs systems and maintain relatively constant conditions within the extracellular fluid.

The essence of health care is to recognize and understand the effect that mechanical, nutritional, and/or emotional stress is having on the body's ability to maintain homeostasis. This process allows the **correction and avoidance of chronic degenerative processes** before they become obvious.


We begin by analyzing and **improving the diet** by reducing obvious excesses and using nutritional supplements to relieve deficiencies:

1. Improve digestion to move nutrients past an incompetent digestive system and to reduce cravings.
2. Normalize bowel function
3. Nourish the immune system to provide for an adequate inflammatory response.
4. Assist with the 2nd phase of recovery and tissue repair.
5. Provide nutrients for the autonomic nervous and endocrine systems so they can maintain normal function.
