My name is Roxanne Griffin. I am a Critical Care Registered Nurse with extensive experience in patient care. My experience is not only as a healthcare professional but also as the spouse of a disabled Gulf War veteran who has endured immense suffering due to a severe back injury and PTSD.

For years, I have witnessed the debilitating effects of chronic pain and the toll it takes on one's mental health and family life. Prescription opioids, while effective for pain management, have rendered my husband too sedated to engage in the simplest of family activities, robbing him and our children of precious moments together.

However, our lives transformed during a family vacation when a friend suggested the natural plant, kratom. The impact was immediate and life changing. Please remove Mitragynine and 7-OH Mitragynine from the Wisconsin Controlled Substances List and support the passage of the Kratom Consumer Protection Act. My name is Billy Griffin, and I am a proud but disabled veteran, having served as an Army Staff Sergeant during the Desert Storm Gulf War. My service to our country left me with a severe back injury and PTSD, which has significantly limited my mobility and quality of life.

The prescribed opioids that I have been given to manage my pain have proven to be a double-edged sword. While they offer some relief, they come with debilitating side effects such as bowel obstruction and extreme fatigue, not to mention the psychoactive effects that cloud my mind. These side effects prevent me from being the active father I strive to be for our three boys. The fear of respiratory depression is so great that I dare not take these medications at night, which only exacerbates my chronic pain and anxiety.

During a family vacation to Disney World—a rare moment of respite—I had the opportunity to try kratom. The impact was immediate and profound. For the first time in a long while, I experienced a significant reduction in my pain levels and anxiety. More importantly, I was free from the PTSD flashbacks that frequently haunt me, and I slept through the night peacefully.

The difference kratom made in my life was nothing short of remarkable. It allowed me to be present and engaged with my family, to enjoy life's simple pleasures without the looming shadow of pain and anxiety.

Unfortunately, back home in Wisconsin, kratom is scheduled as a controlled substance, which puts it out of my reach. Dear Chair Englebert and Members of the Board,

My name is Heidi Sykora and I am a resident of Grafton, Wisconsin. I am writing to express the significant hardship that the current legal status of kratom in Wisconsin imposes on my life and well-being.

I suffer from multiple chronic conditions, including Chiari Malformation, Tethered Spinal Cord, Ehlers-Danlos Syndrome, Hereditary Alpha Tryptasemia, and Thoracic Outlet Syndrome. These conditions cause me persistent pain and discomfort, severely impacting my quality of life.

Due to the prohibition of kratom in Wisconsin, I divide my time between Wisconsin and Illinois. In Illinois, kratom is legal and provides me with essential relief from the constant pain I endure. This necessity to travel imposes not only a physical and emotional burden but also a financial one, as I must maintain residences in two states.

In Wisconsin, the prohibition of kratom—a plant that has been instrumental in managing my pain—forces me to live a fragmented life. To access the relief that kratom provides, I must travel to Illinois, where it is legal. This division of my existence between two states is more than an inconvenience; it is a source of physical strain, emotional distress, and financial burden. My husband's longstanding career in real estate and public service in Wisconsin underscores our deep roots in this community. Yet, the legal constraints on kratom mean we are too often separated.

As Dr. Christopher McCurdy describes it, Kratom's unique "symphony" of alkaloids has been a cornerstone of my pain management. It effectively alleviates the intense nerve pain that I experience in my spine and chest. It allows me to exercise and stretch which is essential for preventing further debility.

The legal status of kratom in Wisconsin forces me to make difficult choices that no individual seeking relief from chronic pain should have to make. The current law not only restricts my access to a natural remedy that significantly improves my condition but also limits my ability to participate fully in my community and live a stable life.

I appeal for the exclusion of Mitragynine and 7-Hydroxymitragynine from the scheduled substances list, or alternatively, to cap the presence of 7-Hydroxymitragynine at a maximum of 1% in any given product. Subsequently, I advocate for the enactment of the Kratom Consumer Protection Act to ensure a secure and regulated framework for its use.

I urge you to consider the implications of kratom's legality on individuals like me who rely on it for pain relief. Legalizing kratom in Wisconsin would not only alleviate the hardships imposed on us but also provide a regulated, safe framework for its use.
