

## Wisconsin Municipalities with Commercial Plumbing Plan Review Delegated Authority – May 1, 2024

## Wisconsin Administrative Code § SPS 382.20(2)

This section establishes the manner under which cities, villages, towns, and counties may perform commercial plumbing plan reviews under <u>Wisconsin Statute § 145.05(5)(a)</u>.

**1.** Municipalities delegated responsibilities under <u>Wis. Admin. Code § SPS 361.20(1)(b)</u> are delegated to perform plan reviews of the installations listed below [<u>Wis. Admin. Code § SPS, Table 382.20-2</u>].

- New installations, additions, and alterations to drain systems, vent systems, water service systems, and water distribution systems involving 16 or more plumbing fixtures to be installed in connection with public buildings.
- Grease interceptors to be installed for public buildings.
- Garage catch basins, carwash interceptors and oil interceptors to be installed for public buildings and facilities.
- Sanitary dump stations.
- Piping designed to serve as private water mains.
- Piping designed to serve as private interceptor main sewers greater than 4 inches in diameter when sized for gravity flow.
- Stormwater systems, not including infiltration plumbing systems, serving a public building or facility where the drainage area is one acre or more.
- Mixed wastewater holding device.

• 1<sup>st</sup> Class City Only: Water supply systems and drain systems to be installed for manufactured home communities and campgrounds and chemical waste systems regardless of the number of plumbing fixtures.

**2.** All plumbing, new installations, additions and alterations, regardless of the number of fixtures involved, serving hospitals, nursing homes, and ambulatory surgery centers, renal dialysis centers, community-based residential facilities (CBRF), and impatient hospice. [SPS Table 382.20-1, Item 1] Note: Potable water treatment by use of injection of a solution into the water supply system can only be reviewed by the Department per Table 382.20-1. Examples include, but not limited to, .5 mg/L residual chlorine, chloramine, or chlorine dioxide.

**3.** Stormwater and clearwater detention, treatment, and infiltration plumbing systems service a public building or facility. [SPS Table 382.20-1, Item 6]

**4.** Onsite residential and commercial water reuse treatment systems, designed to treat water for compliance with Table 382.70-1. [SPS Table 382.20-1, Item 7]

5. Mixed wastewater holding device. [SPS Table 382.20-1, Item 11]

Per <u>Wis. Admin. Code § 382.20(2)(b)</u>, a delegated municipality may waive its jurisdiction for plan review and approval of any project. To do so, the municipality must provide the Department with a written request prior to the plans being submitted.

Note that pursuant to <u>Wis. Admin. Code § SPS 382.20(2)(a)</u>, a municipality has the authority to perform commercial plumbing inspections, without delegation from the Department, if the municipality utilizes properly certified inspectors.

The following table identifies the municipalities that are delegated the primary responsibility to perform commercial plumbing plan review under Wis. Admin. Code § SPS 361.20(1)(b). The list includes:

- Each municipality's delegated plan review responsibilities, as numbered above, under its Wis. Admin. Code § SPS 382.20 delegation authority.
- A link to each municipality's delegated authority approval letter from the Department. (Click on the number in the Delegation Authority column to view the municipality's approval letter.)
- Municipal and plan reviewer contact information for each municipality. Note the municipality's delegation is not contingent on the specific individuals identified on this list or in the linked approval letter.
