

MMA PROFESSIONAL BOUT CONTRACT

This contract is made this ____ day of _____, 2013, by and between _____ of the City of _____ and State of _____, a promoter

duly licensed under the laws of the State/Tribe of Wisconsin (License # _____) (hereinafter “Promoter”), and _____ of the City of _____ and State
(*Contestant*)
of _____, a mixed martial arts professional fighter whose Federal ID # is _____ (hereinafter “Contestant”). This contract is subject to the laws of the State of Wisconsin.

Parties agree to abide by all rules governing MMA fighting in the State of Wisconsin, specifically Wis. Stat. Chapter 444 and Wis. Admin. Code §§ SPS 192 through SPS 196 and the unified rules for mixed martial arts established by the Association of Boxing Commissions (ABC), where applicable.

Parties agree that if Contestant is not already duly licensed as a mixed martial arts professional fighter in the State of Wisconsin, that the parties will submit a complete license application for contestant no later than 10 business days prior to the scheduled event.

I. Bout

Contestant agrees to enter into a professional mixed martial arts contest to be held at _____, Wisconsin, on the ____ day of _____, 2013. The bout will be

Federal ID # is _____. This contest shall be at a weight not over _____ pounds, said weight to be taken on certified scales. Contestant agrees to appear at the weigh-ins for the bout which shall take place on the ____ day of _____, 2013 at ____ p.m. at _____, Wisconsin. The Bout will be conducted according to the MMA rules
(*Weigh-in Venue*)
of the State of Wisconsin and all officials will be duly licensed by the State of Wisconsin.

Contestant agrees to arrive to the weigh-in at the time agreed upon and to the bout two hours before the time set for the event. Contestant understands that failure to make contracted weight and/or weigh in inside of their weight class may result in discipline, namely a forfeiture, suspension or revocation, under Wis. Stat. § 444.11. Contestant understands that reporting to either event after the time set may result in discipline, namely a forfeiture, suspension or revocation, under Wis. Stat. § 444.11. Contestant understands that any discipline, forfeiture, suspension or revocation will be reported to the ABC national database.

II. Compensation

III. Assumption of Risk

The Contestant understands and agrees that by participating in this bout, Contestant is engaging in an abnormally dangerous activity which subjects the Contestant to risk of severe injury or death. The Contestant with full knowledge of risk, nonetheless, agrees to enter into this agreement and hereby waives any claim that the Contestant or Contestant’s representatives or heirs may have against the State of Wisconsin and/or the Department of Safety and Professional Services as a result of any injury the Contestant may suffer as a result of Contestant’s participation in this contest.

IV. Indemnification and Release

The parties, jointly and severally hereby indemnify, hold harmless, release and forever discharge the State/Tribe of Wisconsin and the Department of Safety and Professional Services and each of their members, agents and employees in their individual, personal and representative capacities against any and all claims, suits and actions, known or unknown, brought against the persons named in this paragraph by reason of this agreement and all other matters relating thereto, and against any and all expenses, damages, charges and costs, including court costs and attorney fees which may be incurred by the persons and entities named in this paragraph as a result of said claims, suits and actions.

This contract shall be submitted to and approved by the Department of Safety and Professional Services 10 business days prior to the bout.
