WHEREAS, the above bounden principal is about to engage in business as a warehouse keeper in Wisconsin, in
accordance with the provisions of Chapter 440, Wisconsin Statutes, and has applied to the State of Wisconsin for
approval, pursuant to Section 440.92(7), Wisconsin Statutes and Chapter 52, Wis. Admin. Code.

NOW THEREFORE, the condition of this obligation is such that if said principal will pay all amounts that are required for
delivery of cemetery merchandise held by said principal under preneed sales contracts and that may be recovered
(pursuant to a final judgment rendered by a court of competent jurisdiction or based upon a finding by the State of a
violation of Section 440.93, Wis. Stats.) against such principal at any time by the State or any person who has been
damaged by reasons of such principal acting as a warehouse keeper or by reason of the acts or conduct of his/her or its
agents or employees during the term of this bond, then this obligation to be void, otherwise of full force and virtue.

REGARDLESS of the number of years this bond shall continue to be continued in force and of the number of premiums
that shall be payable or paid, the surety shall not be liable hereunder on account of defaults by the principal for a large
amount in the aggregate than the penal sum of this bond.

THE TERM of this bond shall be from _____ to
_____ * at which time it will terminate with respect to the principal, unless renewed
by a Continuation Certificate. The surety may cancel this bond and be relieved of further liability hereunder by delivering
90 days' written notice to the State of Wisconsin, Department of Safety and Professional Services at 4822 Madison Yards
Way, Madison, WI 53705; however, such cancellation shall not affect any liability incurred or accrued hereunder prior to
the termination of the 90-day period.
