APPROVED REAL ESTATE APPRAISAL CONTINUING EDUCATION COURSES

Every appraiser shall complete at least 28 hours (if initially credentialed in the second year of the biennium must complete only 14 hrs) of continuing education in each biennial renewal period, at least 7 of which shall include instruction in the professional standards and code of ethics applicable to appraisers. It is your responsibility as the licensee or certificate holder to verify with the course provider that the courses you take are approved for continuing education credit at the time you take such courses. Courses that have been approved by the AQB do not require separate approval.
