

### Workgroup Request

Motion from 5/11/18 Workgroup Meeting:

MOTION: Peter Kallio moved, seconded by Timothy Westlake, to request that PDMP staff generate reports containing the following data:

- 1. Number of patients with over 300 MMEs per day
- 2. Number of patients with over 300 MMEs with benzodiazepines per day
- 3. Identifying the practitioners prescribing to patients in bullets 1 & 2
- 4. Practitioners with the highest total MMEs monthly
- 5. Pharmacies associated with dispensing to patients identified in bullets 1, 2 & 4
- 6. Patients with highest MMEs and identifying the prescribers
- 7. Practitioner by profession containing number of patients, number of prescriptions, and total doses, identifying practitioners who are 2 standard deviations in 2 of 3 categories
- 8. Prescribers who are not checking PDMP
- 9. Pharmacies who are not submitting data to PDMP

Motion carried unanimously.

# **Overview of Current Data Sources**

- PDMP User Profiles
  - Registration information (profession/specialty)
  - PDMP usage report
- Prescriber Metrics Report Data
  - Monthly report, 100-day rollup
  - Volume of scripts and doses, by class, percentile for profession
- Dispensing Data
  - MME/script
  - # of scripts, days' supply
- Prescriber Reports
  - Identification of patients, co-prescribing
- Dispenser Submission History



## **Dispenser Compliance**

- Number of licensed pharmacies (as of 6/30/18): 2255
- Number of exempt pharmacies: 506
- Number of dispensers expected: 1749
- Number of dispensers on record (June): 1633 (93% compliance)



## **Prescriber Compliance**

- Number of DEAs with dispensings (does not take into account exceptions to review requirement): 46,288
- Number of registered prescribers: 22,609
- Registered with no patient queries in June: 5,420 (3,739 with fewer than 20 rx)
- Focus?
  - Number of those not registered who have prescribed opioids
  - Prescribers who have fewer than 100 opioid rx/mo
  - Prescribers who have high volume of short duration rx
- Outreach opportunity
  - Requirement
  - Benefits of checking, having an account

- 1. Hydrocodone-Acetaminophen Tab
- 2. Hydrocodone-Ibuprofen Tab
- 3. Oxycodone HCl Cap
- 4. Oxycodone w/ Acetaminophen Tab
- 5. Oxycodone-Aspirin Tab

#### **Prescriptions written for 3 days or less**: 45,519

### **Total number of prescriptions written for 10 or more pills per day**: 13,137

- Number of DEA Numbers/Prescribers: 4,430
- 219 Prescribers wrote 10 or more prescriptions in February for over 10 pills per day, accounting for 25% of the 13,137




### Patient MME



#### Prescriber Metrics Based on Volume of Prescriptions






