MOTION: Christopher Webster moved, seconded by Lindsey Marsh, to delegate to DSPS Chief Legal Counsel the authority to act on behalf of the Board concerning stipulated resolutions providing for a surrender, suspension, or revocation of a credential, where the underlying merits involve serious and dangerous behavior, and where the signed stipulation is received between Board meetings. The Board further requests that CLC only act on such matters when the best interests of the Board, Department and the Public are best served by acting upon the stipulated resolution at the time the signed stipulation is received versus waiting for the next Board meeting. MOTION: Lindsey Marsh moved, seconded by Christopher Webster, to delegate authority to the Department Attorneys to review and approve applications with convictions which are not substantially related to the practice of Marriage and Family Therapy. Motion carried unanimously.

MOTION: Lindsey Marsh moved, seconded by Patrick Stumbras, to delegate authority to Department staff to approve applications where Applicant's prior discipline has been approved for a previous Marriage and Family Therapy credential and there is no new discipline. Motion carried unanimously.

MOTION: Lindsey Marsh moved, seconded by Patrick Stumbras, to delegate authority to the DPCP Legal Team Attorneys and Paralegals to review and approve Applicant's proposed Evaluators/Assessors for AODA and FTP assessments, unless the request specifically requires full Section or Section liaison approval. Motion carried unanimously.

Pre-Screening Delegation to Open Cases

- **MOTION:** Lindsey Marsh moved, seconded by Christopher Webster, to delegate prescreening decision making authority to the Department screening attorney for opening cases as outlined below:
 - 1. OWIs of 3 or more that occurred in the last 5 years.
 - 2. Reciprocal discipline cases.
 - 3. Impairment and/or diversion at work that includes a positive drug/alcohol test or admission by respondent.
 - 4. Conviction of a misdemeanor or felony that the attorney believes is substantially related and is not otherwise excluded from consideration via Wis. Stat. ch. 111.
 - 5. No response from the respondent after intake requested a response (case would be opened for the failure to respond issue as well as the merits).

Motion carried unanimously.

Pre-Screening Delegation to Close Cases

- **MOTION:** Lindsey Marsh moved, seconded by Patrick Stumbras, to delegate prescreening decision making authority to the Department screening attorney for closing cases as outlined below:
 - 1. One OWI that is non-work related and if AODA assessment completed, assessment does not indicate dependency.
 - 2. Complaints that even if allegations are true, do not amount to a violation of law or rules.

Motion carried unanimously.

Voluntary Surrenders

- **MOTION:** Lindsey Marsh moved, seconded by Patrick Stumbras, to delegate authority to the assigned case advisor to accept or refuse a request for voluntary surrender pursuant to Wis. Stat. § 440.19 for a credential holder who has a pending complaint or disciplinary matter. Motion carried unanimously.
- **MOTION:** Christopher Webster moved, seconded by Lindsey Marsh, to delegate authority to the Department to accept the voluntary surrender of a credential when there is no pending complaint or disciplinary matter with the Department pursuant to Wis. Stat. § 440.19. Motion carried unanimously.
