Subject: Scope of Practice Issues:

Issue to Address:

<u>The definition of abhyanga is:</u> **Abhyanga** ("oil massage") is a form of Ayurvedic medicine that involves massage of the body with dosha-specific warm herb infused oils. The oil is usually pre-mixed with herbs for specific conditions. (Wikipedia)

With the increased popularity of Ayurveda, it seems as though individuals are practicing Ayurvedic massage without a license. Individuals are being trained under a marketing terms such as "ayurvedic body therapies" and then cosmetologists or estheticians are being trained to do these massage treatments. Traditional Indian massage is called Abyhanga—it is not an oil application---it is a massage that uses medicinal oils. Just like Swedish massage is massage, Indian massage is abhyanga Hawaiian Massage is called Lomi-Lomi. This is ALL massage. I recently received an abhyanga massage at a new spa and I thought I was getting a massage only to find out that it was an esthetician providing the treatment. This was an expensive service for one. Secondly, there clearly was no knowledge of anatomy, endangerment sites etc. When I asked her about it, she said she was "free-styling, oil application" What does this even mean?

It was totally unethical. There was also ZERO intake or informed consent. Clearly, these individuals are not being trained appropriately. And, it's not their fault, because they do not know any better. It is the institutions fault, for marketing and leading their students to believe that this is within their scope of practice, when it is not. I have been teaching and directing one of the top programs in massage education for 15+ years. (We maintained a 100% pass rate on our Mblex exam for 11+ years in a row and graduate some of the most successful LMTS in the state. I am not saying this to brag...I am stating this to point out, that I am not just some random person who is bringing up this issue)

I think it is time for the licensing board to ensure that all individuals providing massage are licensed. This includes Thai Massage etc. This is a matter of public safety as well as ensuring that consumers are receiving massage from individuals to receive adequate education in treatment planning, ethics and professionalism.

I have submitted a formal complaint against the AVEDA institute for training cosmetologists to do these massages. I have nothing against the program, however it should be housed under massage therapy—not cosmetology.

I spoke with Jeffrey Montoya about this before I submitted the official complaint and he mentioned that when they were putting this program together, they were planning to have it be under massage therapy. I'm wondering who was involved in that decision? And, why they thought it should be under cosmetology?

I've been in this industry for almost 20 years at this point, teaching and managing an academic program. This seems like individuals who know our industry would understand and have the knowledge categorize Ayurvedic massage accurately. Now more than ever, this is so important. Especially, as massage therapy becomes more integrated into healthcare. Imagine wanting to experience Ayurvedic massage, only to receive a treatment from an esthetician. It does nothing to strengthen our profession and if anything leads consumers to believe that that is what all Ayurvedic bodywork is... It is misleading and unethical.
