## Legislative Update

### Certified Nurse Midwives Administrative Rule N4 Revision Process Beginning

The Legislation and Rules Committee of the Board of Nursing is beginning its review of Chapter N4 of the Administrative Rules that govern the practice of Certified Nurse Midwives. Input from the public, Certified Nurse Midwives, and other stakeholders is welcome in this process as we review the language of the rules to evaluate the need for revisions. The board reviews all Administrative Code on a regular basis to ensure the rules reflect and support current practice. Chapter N 4 has not been formally reviewed in more than a decade and it is the last Chapter that the board is reviewing.

The Board of Nursing Legislation and Rules Committee began discussion of Chapter N4 at its meeting on Thursday, June 13, 2019. Committee meetings typically occur before the regularly scheduled full board meeting. Meetings are held in

Madison at the Department of Safety and Professional Services building, 4822 Madison Yards Way, Second Floor, Conference Room N208. In addition to Chapter N4, the Committee also addressed a few technical changes to Chapter N2 regarding Licensure. The changes of Chapter N2 pertain to stakeholder feedback regarding the 2014 Chapter revision.

### News from the Wisconsin Center for Nursing

The Wisconsin Center for Nursing is a 501c3 non-profit organization created in 2006 to engage nurse , public and private academic programs, government agencies and related service providers to work together as collaborative partners. This collaboration ensures an adequate, competent and diverse nursing workforce for the people of Wisconsin. Through partnerships with the Wisconsin Department of Workforce Development, the Center strives to accurately and continually collect, analyze and disseminate nursing workforce data to assist health care organizations and academic institutions in fully assessing both nursing resources and nursing education so they are utilized effectively now, and in the future.

#### Work of the Center

1. Conducts educational surveys with the assistance of the Administration of Nursing Education of Wisconsin (ANEW). These surveys assess program-specific data for approved and accredited nursing programs in the state, including recruitment and retention of faculty and students.
2. Analyzes nurse licensure data on a biennial basis:
  - Even-numbered years, Registered Nurses (RNs), odd-numbered years Licensed Practical Nurse (LPNs)
  - Workforce supply and demand, demographics and education trends and detailed characteristics of the nursing workforce
3. Determines key trends in education, employment and practice
4. Identifies implications for nursing practice education and policy
5. Collaborates with key stakeholders to sustain statewide infrastructure to address nursing workforce issues
6. Develops policy recommendations across industry sectors to improve Wisconsin's health workforce

The fourth biennial 2017 Wisconsin LPN Workforce Survey was completed by 11,264 Licensed Practical Nurses (LPNs) and the fifth biennial Wisconsin RN Workforce Survey was completed by 90,143 Registered Nurses. The RN and LPN Workforce Surveys are required by Wisconsin State Statute. The Surveys are conducted by the Wisconsin Department of Safety and Professional Services, the Wisconsin Department of Workforce Development and the Wisconsin Center for Nursing.

## Enforcement Actions of the Board of Nursing

The Board of Nursing, with help from staff at the Department of Safety and Professional Services, can take action against nurses licensed in the state to help protect the profession and the citizens of Wisconsin. ### Disciplinary options available to the Board:

**Reprimand:** A public warning of the licensee for a violation.

**Limitation of License:** Imposes conditions and requirements upon the licensee, imposes restrictions on the scope of practice, or both.

**Suspension:** Completely and absolutely withdraws and withholds for a period of time all rights, privileges and authority previously conferred by the credential.

**Revocation:** To completely and absolutely terminate the credential and all rights, privileges and authority previously conferred by the credential.

### Non-disciplinary options available to the Board:

**Administrative Warning:** Issued if violation is of a minor nature, a first occurrence and the warning will adequately protect the public. The issuance of an Administrative Warning is public information, however the reason for issuance is not.

**Remedial Education Order:** Issued when there is reason to believe that the deficiency can be corrected with remedial education, while sufficiently protecting the public.
