**LEGISLATIVE AND ADMINISTRATIVE RULE MATTERS**

**Discussion of Committee Recommendations Relating to Plumbing Code, SPS 381-387**

*SPS 381: Definitions and Standards*

**MOTION:** Jason Sladky moved, seconded by Scott Chiples, to add the word ‘illness’ each time injury is mentioned in the original as indicated in Proposed Change 1, Table Version 1, and recommend the change as amended. Motion carried unanimously.

***SPS 382: Design, Construction, Installation, Supervision, Maintenance, and Inspection of Plumbing and***

**MOTION:** Jason Sladky moved, seconded by Michael Scherer, to amend Proposed Change 4, Table Version 1 to use ‘camping units’ in place of ‘camping cabins’, to recommend the change as amended, and to recommend creating a note that reflects back to the definition of ‘camping unit’, SPS 327. Motion carried unanimously.

**MOTION:** Fred Gardner moved, seconded by Marc Rhiner, to recommend Proposed Change 5, Table Version 1. Motion carried. Jason Sladky opposed.

**MOTION:** Jason Sladky moved, seconded by Fred Gardner, to recommend Proposed Change 6, Table Version 1 as presented. Motion carried unanimously.

**MOTION:** Jason Sladky moved, seconded by Robert Schmidt, to amend Proposed Change 7, Table Version 1 to remove “in a municipality having a local inspector”, and recommend the change as amended. Motion carried unanimously.

**MOTION:** Michael Scherer moved, seconded by Jason Sladky, to recommend Proposed Change 8, Table Version 1, with the change to ‘camping units’ as in the updated Table 1. Motion carried unanimously.

**MOTION:** Michael Scherer moved, seconded by Fred Gardner, to table Proposed Change 9, Table Version 1. Motion carried unanimously.

**MOTION:** Roger Musolff moved, seconded by Marc Rhiner, to table discussion of Proposed Change 10, Table Version 1 and to request additional information from the Department. Motion carried unanimously.

**MOTION:** Jason Schmidt moved, seconded by Michael Scherer, to table discussion of Proposed Change 11, Table Version 1 until further information is obtained regarding definition of ‘seasonal’. Motion carried unanimously.

**MOTION:** Roger Musolff moved, seconded by Fred Gardner, to table Proposed Change 12, Table Version 1 and to request additional information from the Department about language from other codes relating to the substance of 382.30(11)(a) and 382.30(12)(f). Motion carried unanimously.

**MOTION:** Roger Musolff moved, seconded by Scott Chiples, to recommend Proposed Change 13, Table Version 1 with the note amended to read: “see Ch. 382 Appendix for examples of exposed piping considerations.” Motion carried unanimously.
