K. Complaints Handled:

- Laubenstein vs. PC ProSchools Additional 10% refunded, school and student agreed on the additional refund of \$2,450 to Sallie Mae.
- Krueger vs. PC ProSchools Student asked school allow him to complete certification exams for certifications that Microsoft no longer provides. Student attended in 2004 and was considered withdrawn from the program. EAB found school is no longer under any obligation to the student and school may determine it will no longer allow student to continue taking the certification exams through the school. No further action required.
- Rembalski vs. Bryant & Stratton College Closed in favor of the school, no further action required.
 Nature of the complaint is: Student (through attorney) described computer issues during an on-line exam, and requested removal of failing grade, or chance to re-take exam. School explained test was disrupted when student clicked cursor outside the test screen, which is part of the design to prevent cheating. During this disruption, the clock stopped, but there was no time lost, and student could have resumed the test by clicking the "resume" command.
- *Smigelski vs.High-Tech Institute* Student got sick and had to leave her internship because she was allergic to the carpeting the building owners were installing. The school did not find her a new place to intern. Eventually school found externship. No further action required.
- Hussein vs. Sanford-Brown College Milwaukee Student complained a teacher retaliated against her, the results of her competency tests were not documented, the school had an unprofessional climate, her work study pay was miscalculated and paid late at times, students are not told until late in the program about certain medical assessments they must have done, and students are promised outrageous pay upon graduation and placement. School provided documentation successfully refuting the allegations. An unannounced site visit by two EAB consultants found no substantial evidence to the student's allegations. Complaint closed September 2, 2008.

L. School Status Change:

 Professional Dental Assistant Training – School changed from Inactive to Active status effective Friday, August 15, 2008.
