#### **SCOPE & STRATEGIC PLAN**

#### LOOKING FORWARD, 2024-2028

#### GOALS YEARS TWO & THREE, OCTOBER 2024- OCTOBER 2026

- Continue to provide the Wisconsin Fire Safety Dashboard- Risk Reduction Tool (Craig 1300) & Statewide CRR Program awareness, information and training opportunities through classes, conferences (State Fire Chiefs, State Fire Inspectors & State Firefighters Conferences), workshops, seminars, webinars, articles and website resources. Discuss the importance of accurate and timely incident reporting.
- Encourage local fire departments to formalize their approach to community risk reduction through developing and implementing a CRR plan and provide quality, demographic, age-appropriate, and evidence based educational safety materials, with consistent messaging and common language, for local distribution.
- Provide education on incentive and grant opportunities to agencies, fire departments, and local communities that implement CRR (i.e. tie CRR to funding initiatives, smoke alarms for home visits, home sprinkler tax incentives, etc.) and provide guidance on how to develop local partnerships.
- Provide recognition to WI communities for CRR efforts through the WI Burning Report and in the form of awards and establish a statewide "CRR Day" for recognition of local community CRR programs.
- Evaluate Wisconsin Fire Safety Dashboard- Risk Reduction Tool (Craig 1300), initiative, data usage and analysis, trends, and potential risk reductions. Determine additional program needs and evaluate program value or growth.


#### GOALS YEARS THREE-FIVE, OCTOBER 2026-OCTOBER 2028

- Create a state CRR expert network, speaker's bureau, and leadership team to teach, mentor, coach, and advocate for CRR and associated strategies within the state and assist communities in developing and implementing their CRR supported programs.
- Provide education on funding opportunities to support local CRR implementation; available resources for grant writing and advocate for additional CRR grant funding resources.
- Partner with Wisconsin Technical College System to incorporate CRR into all levels of state of Wisconsin training standards (ELF, Firefighter I/II Fire Officer I/II, Fire Inspector.)
- Create a CRR standardized program evaluation and follow-up form. Promote and create an awareness of learned successes from CRR initiatives.
