



Wisconsin Municipalities with Delegated Authority for the Uniform Dwelling Code (UDC) and for Camping Units – **As of May 31, 2020**

Wisconsin Administrative Code § SPS 320.06(1).

Except as provided in ss. 101.651 (1) and (2m), Stats., cities, villages, and towns shall exercise jurisdiction over the construction and inspection of new one- and two-family dwellings provided the municipality complies with the following:

1. The municipality's ordinances adopt Wis. Admin. Code § SPS 320 in its entirety.
2. The municipality uses an acceptable method of enforcement.
3. The municipality files a certified copy of all ordinances adopting the Uniform Dwelling Code.

Delegated Authority for Counties of Adams, Bayfield, Buffalo, Chippewa, Dane, Eau Claire, Florence, Forest, Iron, Langlade, Marquette, Richland, Trempealeau, Waupaca, and Waushara: These counties have been authorized jurisdiction over the construction and inspection of new one- and two-family dwellings in cities, villages, and towns which do not have their own delegated authority.

The following table includes the delegated authority approval letter from Wisconsin Department of Safety and Professional Services for each delegated city, village, town, and county.

Wisconsin Administrative Code § SPS 327.06(1).

Except as provided in Wis. Admin. Code § SPS 327.06(1)(b), cities, villages, towns, and counties approved by the department under Wis. Stat. § SPS 320.06 to exercise jurisdiction over the construction and inspection of new one- and two-family dwellings shall also exercise jurisdiction over the construction and inspection of new camping units.

Prior to May 7, 2017, a city, village, town, or county delegated under Wis. Admin. Code § SPS 320.06 had the option to renounce delegation under Wis. Admin. Code § SPS 327.06. Cities, villages, towns, and counties that have renounced delegation of construction and inspection of new camping units are noted in the below table with their “Opt-Out Letter” in the Camping Units Delegation column.

Delegated Authority for Counties of Adams, Bayfield, Buffalo, Dane, Florence, Forest, Iron, Langlade, Marquette, Richland, Trempealeau, and Waupaca: These counties have been authorized jurisdiction over the construction and inspection of new camping units in cities, villages, and towns which do not have their own delegated authority.
