## UTILITY CONTRACTOR LICENSE APPLICATION INFORMATION

### **Requirements for Credential**

Per Wis. Stat. § 145.06, no person may engage in or work at plumbing in the state unless licensed to do so by the Department.

Per <u>Wis. Stat. § 145.07(10)</u>, the Department shall issue a Utility Contractor license to any person who is skilled in the planning, superintending and practical installation, within public or private premises, of piping which conveys sewage, rain water, or other liquid wastes to a legal point of disposal and who is skilled in the design, planning, superintending and practical installation of water service piping from the street main to the immediate inside building perimeter.

Per <u>Wis. Admin. Code § SPS 305.97</u>, a person who, as a licensed Utility Contractor, installs or modifies water services, private water mains, sanitary building sewers, storm building sewers, or private interceptor main sewers shall utilize the appropriately licensed or registered persons to install or modify the plumbing.

#### AN APPLICATION IS NOT COMPLETE UNTIL ALL OF THE FOLLOWING DOCUMENTS HAVE BEEN RECEIVED:

- 1. <u>Application and Fees</u>: Apply and pay fees online in LicensE, <u>https://license.wi.gov</u>. Fees will be calculated in LicensE. If needed, you can save your application and complete and submit it later. **NOTE:** If DSPS requests additional documents they must be uploaded within three (3) months from the date they were requested. Failure to do so may result in having to submit a new application and pay fees.
- 2. Qualification for Examination: A person applying for a Utility Contractor license examination shall be at least 18 years old.
- 3. Examination: You will be made eligible to test after your application has been submitted and reviewed. If additional documents are required you will be made eligible to test after all documentation has been received and reviewed. A communication will be sent once you are made eligible to test. Please check your "junk" or "spam" email folders.
