Wisconsin to Pilot Maintenance of Licensure

At its February 17, 2011 meeting, the Medical Examining Board approved a motion requesting that the Federation of State Medical Boards (FSMB) consider Wisconsin as a pilot state for "Maintenance of Licensure" (MOL).

In 2010, the House of Delegates of the FSMB approved a policy framework for Maintenance of Licensure (MOL) recommending that all U.S. physicians, as a condition of licensure renewal, "should provide evidence of participation in a program of professional development and lifelong learning." The MOL framework proposes three components: reflective self-assessment, assessment of knowledge and skills, and performance in practice.

The Wisconsin Board action was a result of discussions about how to encourage and support lifelong learning by licensed physicians and efforts to confirm and enhance physicians' practice improvement

efforts. Currently when Wisconsin physicians renew their licenses, they are required to attest to completion of the current continuing education requirement of 30 credits in two years. Physicians nationally and in Wisconsin have been dedicated in their efforts to create a system that is more evidence-based, practice relevant, and capable of measuring outcomes within a practice and in relation to one's peers. Maintenance of Licensure is intended to accomplish all three objectives. Humayan Chaudhry, President and Chief Executive Officer of the FSMB, said, "The FSMB is delighted to be working closely with the Wisconsin Medical Board to consider ways in which it can consider pilot projects to implement Maintenance of Licensure (MOL) for its physicians. It joins 11 other state medical and osteopathic boards interested in doing the same."

Too Close For Comfort

Practical Tips to Avoid Professional Boundary Issues

Boundary violations occur when the best interests of patients give way to the physician's sexual, financial, emotional or political interests. Boundary cases are evaluated in context, however physicians should not assume that their motivation or the patient's conduct will absolve the physician of ethical or legal responsibility. The physician is responsible for maintaining proper boundaries in the physician-patient relationship; patients may not view the conduct as harmful to them.

Examples of boundary violations include:

- A physician loans a patient the physician's vacation home in appreciation for the long-standing professional relationship;
- A physician alters third-party billing records for the patient's financial benefit:
- A physician fails to file a court report on time and compensates the patient for the physician's lapse;
- A physician has romantic or sexual motivation for their conduct, including conduct that is not overtly sexual (without medical justification, physician intentionally brushes against the patient's intimate body parts, whether clothed or unclothed);
- During the professional relationship, a patient pursues a personal relationship with the physician, they fall in love

counsel for the MEB. She has served as a prosecutor for DRL for many years and thus brings valuable insight to our discussions.

Our 2010 <u>Annual Report</u> was released a few months ago. I encourage you to review it if you have not already done so.

Highlights include:

- Over 2,000 new physician credentials are issued annually and 22,000 licenses are renewed biennially;
- The average time to review new documentation for license applications has been reduced from 10-15 business days to 7;
- In almost all cases, licenses are issued on the same day that all documents are received and all requirements are met;
- Processing time for license verifications has been reduced from 10-15 business days to 5;
- Over 90 percent of licenses are renewed online, which has streamlined the renewal process;
- For the year 2010 the Board closed 457 cases, 54 with formal Board Orders. An additional

- significant number were closed informally with Administrative Warnings;
- The department resolved 90% of cases that were opened for investigation within 18 months.

Future and ongoing Board activities include:

- **Participation** pilot in program to assess and implement Maintenance of Licensure (MOL). The Board has reviewed multiple options and will work with the Federation of State Medical Boards (FSMB) as we move forward with this important project (see article, page one);
- Updating Wis. Admin. Code Chapter MED 10, the Board's Unprofessional Conduct Rule, to make it applicable to present practice conditions;
- Updating Wis. Admin. Code Chapter MED 8, the Board's Physicians Assistants Rule. A work group is currently reviewing the possibility of increasing the Physician to Physician Assistant supervision ratio from the current limit of 1:2;
- Work on a \$500,000 American Recovery and Reinvestment (ARRA) grant that unifies application and credentialing processes across multiple states is progressing well. Discussions continue with the

states involved;

 Creation of a uniform application form that will reduce filing requirements for license applicants and eliminate redundancies when applying for licensure in other states.

Board member activities include:

- Gene Musser Serves on the FSMB's Physician Reentry Task Force;
- Sandra Osborn Serves on the Editorial Board for the FSMB's *Journal* of *Medical Licensure* and the USMLE Item Writing and Standard Setting Committee;
- Sujatha Kailas is serving a 3 year term on the USMLE Step 3 Committee.

As a reminder, the biennial renewal is in the fall this year. Watch your mail for the yellow postcard announcing the opening of the online renewal process. Also included during this renewal time is an online survey conducted by the Department of Workforce Development. We ask that you take a moment to complete the survey, as the data collected will be valuable for ongoing workforce analysis and shortage area designation.

and later marry;

A physician continues prescribe narcotic medications past the point of objective iustification medical because the physician sympathizes with the patient's circumstances and in doing so the physician feels personally magnanimous.

Physicians are advised to consider practices and policies that protect physician and patients from boundary concerns. Physicians may:

- Implement and enforce a written policy prohibiting all staff from engaging in social, financial, and/ non-professional or relationships with adult patients until 2 years after a treating relationship has ended, and with child patients, at least 2 years after the treating relationship ends and/or 2 years after the child reaches the age of majority (Wis. Admin. Code § 10.02(zd));
- Use chaperones liberally, implement and enforce a written policy of using chaperones liberally, and document the chaperone's presence, including the patient's signature in acknowledgment;
- As part of informed

- consent discussions, carefully explain to the patient any anticipated procedure that may create incidental contact with a patient's intimate parts--including the nature, necessity, and purpose of the contact--document doing so, and obtain the patient's signature acknowledging that you have done so (Wis. Admin. Code §§ 10.02(u) and (za));
- Impose and enforce written policies against exchanging, giving or accepting anything of value with patients except legitimate payment for health care services actually provided (Wis. Admin. Code § 10.02(zd));
- Avoid discussions of sexual or financial matters, unless

- germane to legitimate medical care;
- Never discuss sexual matters with children unless properly supervised and the discussion is necessary to a legitimate medical issue, and never refer to a child in a sexual connotation, even in jest;
- Rigorously follow professional standards in prescribing medications at risk for abuse;
- Document, document, document.

All physicians must rigorously assess their own practices and intervene at the earliest sign that boundaries may have been compromised. In many instances, consultation with a colleague may be helpful.

Enforcement Actions of the Medical Examining Board

The MEB has the following options available for discipline of a licensee:

Administrative Warning – Issued if a violation is of a minor nature, a first occurrence and the warning will adequately protect the public. Not reported to the National Practitioners Data Bank (NPDB). The content of the warning is confidential.

Remedial Education Order - Issued when there is reason to believe that the deficiency can be corrected with remedial education, while sufficiently protecting the public. This is not reported to the NPDB.

Reprimand – A public warning of the Licensee for a violation. This is reported to the NPDB.

Limitation of License – Imposes conditions and requirements upon the licensee, imposes restrictions on the scope of the practice, or both. This is reported to the NPDB.

Suspension – Completely and absolutely withdraws and withholds for a period of time all rights, privileges and authority previously conferred by the credential. This is reported to the NPDB.

Revocation - To completely and absolutely terminate the credential and all rights, privileges and authority previously conferred by the credential. This is reported to the NPDB.

Adminstrative Warnings January-June 2011

During the first six months of 2011, the Board issued 5 administrative warnings. Administrative warnings are nondisciplinary and their content is confidential. In the past three years, the conduct most often underlying administrative warnings has included record-keeping violations and minor issues in prescriptive practices. Health care professionals are advised to insure timely, accurate and complete patient health care records are created for every patient contact, and particularly where a prescription order is issued.

Board Orders

January 2011

Michael N. Mangold, Physician, West Bend, WI

The Medical Examining Board reprimanded Dr. Michael N. Mangold for repeated failure to maintain patient health care records placing patients at unacceptable risk of harm. The Board limited Dr. Mangold's license by requiring a professional mentor to review randomly-selected patient health care records for two years. The records will be evaluated on a weekly, then monthly basis, for timeliness and compliance with <u>Wis. Admin. Code § Med 21.03.</u> Dr. Mangold must also retain a billing service.

Charles D. Morgan, Physician, Neenah, WI 54956

The Medical Examining Board accepted the surrender of Dr. Charles D. Morgan's license to practice medicine after finding Dr. Morgan had engaged in sexual contact with his psychiatric patient. If Dr. Morgan seeks to reinstate his license to practice medicine and surgery he must first provide evidence satisfactory to the Board that he does not have any psychiatric, chemical abuse or dependency condition that would interfere with his ability to safely provide professional services to patients.

Michael J. Muise, Physician, Freeport, IL

The Medical Examining Board suspended Dr. Michael J. Muise's license to practice medicine and surgery for a 12-month period, but issued an immediate stay of the suspension contingent upon his compliance with the Board's Order. The Board found that Dr. Muise, while working in Illinois, had repeated non-forcible sexual contact with a former patient, with whom

he also had another impermissible relationship. Dr. Muise self-reported the violation to an employer and engaged in mental health assessment and treatment. The Board limited Dr. Muise's license to require that he provide a copy of the Board's order to his current supervisor and any future supervisor, participate in monthly sessions with a psychotherapist, successfully complete comprehensive remedial education on professional boundaries, and submit to monitoring by a professional mentor. Dr. Muise's supervisor, therapist, and professional mentor must submit quarterly reports to the Department Monitor.

Joel S. Stoeckeler, Physician, Hudson, WI

The Medical Examining Board reprimanded Dr. Joel S. Stoeckeler for conduct which fell below the standards of minimal competence during the time he assumed responsibility for his patient's warfarin management. The Board limited Dr. Stoeckeler's license requiring him to complete 8 hours of remedial education in warfarin management within 12 months of the Board's order.

John C. Egan, Physician, Phoenix, AZ

The Medical Examining Board found that Dr. John C. Egan, while practicing in another jurisdiction, failed to appropriately evaluate a patient's acute-onset post-operative pain with focal neurological deficits, and failed to obtain a timely neurosurgical consult. The Board reprimanded Dr. Egan and limited his license to require four hours of remedial education in the diagnosis and management of acute back pain, including post surgical pain.

The Wyoming Board of Medicine disciplined Dr. William S. Fitterman, D.O., for failing to maintain accurate and complete medical records, failing to provide records to patients upon request, and failing to timely respond to the Wyoming Board of Medicines' request for documents. The Wyoming Board placed Dr. Fitterman's license on five years' probation. The Wisconsin Medical Examining Board reprimanded Dr. Fitterman and limited his license to practice medicine and surgery. The limitation will be removed upon the Board's determination that Dr. Fitterman has successfully complied with all of the terms and conditions of the Wyoming Consent Decree.

Theodore Galvani, Jr., Physician, Spring Grove, IL

The Medical Examining Board accepted the surrender of Dr. Theodore Galvani's license to practice medicine and surgery based on discipline imposed by the Illinois Medical Licensing Board. The Illinois Board placed Dr. Galvani on indefinite probation after he was convicted of disorderly conduct while intoxicated. Dr. Galvani may not apply for reinstatement of his Wisconsin credential unless he first obtains consent from the Board or its designee before applying for reinstatement or renewal, and pay \$1,500 in costs. His credentials may be reinstated in the future only if he first establishes to the Board's satisfaction he is professionally competent to re-enter the practice of medicine. If the Board reinstates or renews Dr. Galvani's license the Board may impose additional terms and conditions.

Jeffrey C. Hamm, Physician, Hollywood, FL

The Medical Examining Board reprimanded Dr. Jeffrey Hamm for having his license limited by the Florida Board of Medicine, and now requires Dr. Hamm to notify the Board in advance if he ever returns to Wisconsin. The Florida Board of Medicine reprimanded Dr. Hamm for two separate quality of care violations: (1) during a blepacoplasty and lipoplasty, Dr. Hamm continued with elective surgery despite abnormal intraoperative blood test results; and (2) in preparation for a liposuction procedure, Dr. Hamm cleared a patient for surgery after pre-operative testing indicated dangerously high blood glucose levels without any further testing. Dr. Hamm's Florida license to practice medicine and surgery was subjected to probation, supervision and other significant limitations due to the underlying violations.

Kenneth J. Kurt, Physician, Racine, WI

The Medical Examining Board accepted the surrender of Dr. Kenneth J. Kurt's license to practice medicine and surgery due to his recent retirement. If Dr. Kurt seeks to regain his license he must provide proof sufficient to establish that he does not suffer from any condition which would interfere with his ability to practice medicine and surgery with reasonable skill and safety.

Andrea M. Nunez, Respiratory Care Practitioner, Rockford, IL

The Medical Examining Board found that Ms. Andrea M. Nunez, R.C.P., practiced while under the influence of cocaine. Ms. Nunez' credential is currently expired. The Board ordered that Ms. Nunez may not reapply for licensure to practice respiratory care in Wisconsin and prohibited the Department from processing any future renewal application.

Alex A. Pasquariello, Physician, Middleton, WI

The Medical Examining Board reprimanded Dr. Alex A. Pasquariello for having his credential limited in another jurisdiction. The New York State Board for Professional

Medical Conduct and the Office of Professional Medical Conduct took action against Dr. Pasquariello's license for failing to adequately diagnose and treat three patients whose respective symptoms were: right elbow pain, a history of neck swelling, and a medical history of metastatic colon cancer. Dr. Pasquaariello satisfactorily completed a period of supervision and mentoring in New York.

Ram D. Pathak, Physician, Marshfield, WI

The Medical Examining Board reprimanded Dr. Ram D. Pathak for failing to follow-up with the results of his patient's CT scan. The Board limited Dr. Pathak's license, requiring twelve hours of remedial education in responding to abnormal physical and laboratory findings and early diagnosis and management of cancers.

The Medical Examining Board reprimanded Dr. Juanilito Seldera for conduct which fell below the minimum standard of competence in the profession during the time he conducted his patient's Nissen fundoplication procedure. The Board recognized Dr. Seldera's completion of 4.5 hours of remedial education on advanced laparoscopy at the University of Chicago entitled, "Minimally Invasive Treatment of Esophageal Disorders."

Paul M. Zerovec, Podiatrist, Milwaukee, WI

The Medical Examining Board reprimanded Paul M. Zerovec, D.P.M., for prescribing medications for pain in a manner which tended to constitute a danger to the health, welfare and safety of his patient, as well as having made, with fraudulent intent, false

statements in the practice of medicine. The Board imposed the following limitations on Dr. Zerovec's podiatry practice: for an indefinite period of time he may not order, prescribe, administer or dispense Schedule II controlled substances; he may possess Schedule II controlled substances only if they are prescribed by another practitioner for his personal health care; in any twelve-month period Dr. Zerovec may order, prescribe, administer or dispense to any patient no more than one non-renewable prescription or a one-month supply of a Schedule III, IV or V controlled substance to address acute pain. This limitation shall remain in effect until Dr. Zerovec provides proof to the Board that he has completed intensive remedial education on controlled substances management and medical record keeping.

Thomas J. Carlson, Physician, Fond Du Lac, WI

The Medical Examining Board ordered Dr. Thomas J. Carlson to refrain from reapplying for registration to practice medicine and surgery in Wisconsin at any time in the future. The Department will not process any future applications of renewal of Dr. Carlson's registration due to his retirement from the practice of medicine and surgery.

The Medical Examining Board reprimanded Dr. John G. Schuetz for providing substantial amounts of pain medications to a patient without documenting or maintaining records of narcotics agreements, documenting functional treatment goals or documenting his patient's progress towards those goals. Dr. Schuetz has retired from the practice of medicine. If Dr. Schuetz decides to return to active practice he must notify the

Board at least 30-days before commencing practice and he must complete a comprehensive course in medical record keeping. If his return to practice requires him to prescribe narcotics, he must complete remedial education on pain management or pain management in general practice.

Eric B. Schwietering, Physician, Milwaukee, WI

The Medical Examining Board revoked Eric B. Schwietering, M.D.,'s license to practice medicine and surgery after he was convicted of possession of child pornography, exposing genitalia and 4th degree sexual assault. Dr. Schwietering, whose license was suspended during the pendency of the Board's investigation, may not reapply for restoration of his license; unless he has complied with the Board's order, paid costs and fees, and obtained written recommendations for reinstatement from all health care professionals that have provided sex offender and AODA treatment to him. The Board retains sole discretion as to whether or not it will grant Dr. Schwietering licensure in the future and may impose any conditions or limitations it deems necessary.
