BON Legislative Committee Update

The Legislation and Rules Committee is a subcommittee of the Board of Nursing. Once a scope statement is created and approved by the Governor, this committee works on revisions to an Administrative Rule before taking a draft of proposed changes to the full board. Currently, we are revising N1, Approval for Schools of Nursing. We have reviewed information from other states and the National Council of State Boards of Nursing (NCSBN). We have had lively discussions regarding important issues such as faculty qualifications, faculty exceptions, approval of post-licensure programs, and the NCLEX pass rate standard.

Pilot Questions for the Next Generation NCLEX Roll Out in July

2017 NCSBN Mid-Year Conference Report

The National Council of State Boards of Nursing (NCSBN) held their Mid-Year Meeting in Salt Lake City, Utah in March. Board member Luann Skarlupka and Executive Director Dan Williams represented Wisconsin at the meeting. NCSBN meetings are key opportunities for our Board to keep current with regulatory trends and to exchange insights with other State BONs across the country.

At this meeting, NCSBN announced they will begin piloting new forms of critical thinking and clinical judgment questions for NCLEX test takers beginning in July 2017. Participation in the pilot questions will not be mandatory and will only be offered to the test takers if the standard NCLEX test questions have already been completed within the allotted time.

The pilot questions assess the different steps of the clinical judgment process by utilizing more interactive technology including: extended responses, drag and drop screens, and hot spot identification. The objective of these pilot questions is to gather data on the NCLEX's ability to assess whether new nurses possess the ability to recognize cues, generate hypotheses, evaluate those hypotheses, take action, and evaluate outcomes – all as components of the clinical judgment process.

The Next Generation NCLEX is projected to be implemented in 2021.

Board of Nursing Wisconsin, Department of Safety and Professional Services, Division of Legal Services and Compliance (DLSC) 5 Year and Annual Reports (01/01/2016-12/31/2016)

The Wisconsin Department of Safety and Professional Services' DLSC provides legal services to the Board of Nursing regarding the investigation, prosecution, and discipline of licensed credential holders for violations of statute and administrative rule. At its March 2017 meeting the Board received both a 5-year (1/1/12-12/31/16) and a 2016 Annual Report (1/1/16-12/31/16) from the DLSC which enumerates the Division's activities for the specified time periods. Controlled Substances Board (CSB) Update

The CSB is working hard to keep up with the scheduling of new narcotics being introduced to the public both legally and illegally. The Board met in an emergency session April 3, 2017 to schedule Acryl fentanyl. Scheduling of new substances is an important responsibility of this Board, as it works closely with law enforcement to stay on top of the new substances that appear with increased frequency.

The new Enhanced Prescription Drug Monitoring Program (ePDMP) under Act 266 has been in effect since April 1, 2017. All prescribers of controlled substances are required to register and check on their patients prior to new prescriptions and refills of controlled substances. All Advanced Practice Nurse Prescribers (APNP) are encouraged to register.

On May 12, 2017, the CSB met with law enforcement and prosecutorial entities to get input of trends in the state as it relates to the opioid epidemic. The meeting also gave insight in to what substances are being seized, rates of overdoses, areas of concentration, and overall trends in enforcement as it relates to controlled substances. Enforcement Actions of the Board of Nursing

The Board of Nursing, with help from staff at the Department of Safety and Professional Services, can take action against nurses licensed in the state to help protect the profession and the citizens of Wisconsin. Disciplinary options available to the Board:

Reprimand: A public warning of the licensee for a violation.

Limitation of License: Imposes conditions and requirements upon the licensee, imposes restrictions on the scope of practice, or both.

Suspension: Completely and absolutely withdraws and withholds for a period of time all rights, privileges and authority previously conferred by the credential.

Revocation: To completely and absolutely terminate the credential and all rights, privileges and authority previously conferred by the credential.

Non-disciplinary options available to the Board:

Administrative Warning: Issued if violation is of a minor nature, a first occurrence and the warning will adequately protect the public. The issuance of an Administrative Warning is public information, however the reason for issuance is not.

Remedial Education Order: Issued when there is reason to believe that the deficiency can be corrected with remedial education, while sufficiently protecting the public.
