### **Board of Nursing Legislative Committee Update**

The BON Legislative Committee has completed revisions to N1, Approval for Schools of Nursing. The first approved scope statement allowed the committee to provide clarification regarding school approval. The proposed rule addresses the approval process for schools of nursing with pre-licensure and post licensure programs. The second approved scope statement was specific to requirements related to curriculum and clinical rotations. A public hearing was held on January 11, 2018. After considering public comments,

the full Board of Nursing approved a final draft of the revised rule. Next the rule will go to the Governor and the Legislature for review.

The BON Legislative Committee would like to thank everyone who attended the meetings and provided public comment on the proposed revisions over the past several months. We realize that your time is valuable. We are grateful for your commitment, which was vital to the work of setting appropriate minimum standards for schools of nursing.

## **Enforcement Actions of the Board of Nursing**

The Board of Nursing, with help from staff at the Department of Safety and Professional Services, can take action against nurses licensed in the state to help protect the profession and the citizens of Wisconsin. #### Disciplinary options available to the Board:

violation.

Limitation of License: Imposes conditions and requirements upon the licensee, imposes restrictions on the scope of practice, or both.

Suspension: Completely and absolutely withdraws and withholds for a period of time all rights, privileges and authority previously conferred by the credential.

Revocation: To completely and absolutely terminate the credential and all rights, privileges and authority previously conferred by the credential.

#### Non-disciplinary options available to the Board:

Reprimand: A public warning of the licensee for a Administrative Warning: Issued if violation is of a minor nature, a first occurrence and the warning will adequately protect the public. The issuance of an Administrative Warning is public information, however the reason for issuance is not.

> Remedial Education Order: Issued when there is reason to believe that the deficiency can be corrected with remedial education, while sufficiently protecting the public.

### **Check Your Answers to the Nurse Licensure Compact Questions**

You are grandfathered into the eNLC if you were actively licensed in Wisconsin and held a multi-state license on July 20, 2017.

Act 135 was signed into law on December 11, 2017, making Wisconsin the 27th state to join the eNLC. The eNLC was implemented in Wisconsin on January 19, 2018.

On June 11, 2018, Wisconsin will no longer be part of the original Nurse Licensure Compact California and Minnesota are two of several states that are not in the eNLC.

Florida, Georgia, Oklahoma, West Virginia and Wyoming were not part of the NLC, and have joined the eNLC. If you have a current multistate Wisconsin license, you can now practice in these states.
