We have a number of WOTA Members who are finding 6 month+ delays in receiving their license. We would like the board to consider if there is a way to create a "gap" license while the final one is processed, or another solution to enable OTs and OTAs to begin working while the license processing takes place. This is intended to solve an urgent need, and hopefully a temporary one. We have patients who are facing service delays because of a lack of OTs and OTAs in clinics. We are concerned that treatment delays will create additional health issues.
