## 18 **3.0 Purpose**:

- 19 Pursuant to Section 3.A.5, and Section 10, a state must implement or utilize procedures for considering
- 20 the criminal history records of applicants for initial privilege to practice. These procedures shall include
- 21 the submission of fingerprints or other biometric-based information by applicants for the purpose of
- 22 obtaining an applicant's criminal history record information from the Federal Bureau of Investigation
- and the agency responsible for retaining that state's criminal records. A member state must fully
- 24 implement a criminal background check requirement, within a time frame established by rule, by
- 25 receiving the results of the Federal Bureau of Investigation record search on criminal background check
- and utilize the results in making licensure decisions. The Occupational Therapy Compact Commission
- 27 shall promulgate reasonable and lawful uniform rules to facilitate and coordinate implementation and
- administration of the Occupational Therapy Compact. This rule will become effective upon passage by
- 29 the Occupational Therapy Compact Commission as provided in Section 10 of the Occupational Therapy
- 30 Interstate Compact.

## 34 **3.1 Implementation of Criminal Background Check:**

- 35 To avoid default, member states must have completed all required processes, requirements, and
- 36 applications necessary to request the ability to receive the results of the Federal Bureau of Investigation
- 37 (FBI) record search on criminal background checks, as required by the Compact. Deference will be given
- to member states who can demonstrate that they have engaged in good faith efforts to implement the
- 39 FBI Criminal Background Check including, but not limited to, introduction of related legislation,
- 40 negotiations with FBI state information bureaus, etc.
- Results of the criminal background check shall be reviewed solely by the member state in accordancewith state law.
- 43 Communication between a member board and the Occupational Therapy Compact Commission and
- 44 communications between member boards regarding verification of Occupational Therapist and/or
- 45 Occupational Therapy Assistants' eligibility for a license/privilege through the Compact shall not include
- 46 any information received from the FBI relating to a federal criminal records check performed by a
- 47 member board under Public Law 92-544.
- 48 A member state cannot participate in issuing or recognizing compact privileges until such member state
- 49 has completed the requirements to fully implement the FBI Criminal Background Check requirement.
