Approved Chiropractic Technician Continuing Education Courses

Six hours of approved continuing education (CE) must be completed in each biennial renewal period. Approved courses taken in the current biennium to satisfy the requirements of a previous biennium may not be applied to any other renewal period. All courses must be pre-approved by the Chiropractic Examining Board.

NOTE: A Chiropractic Technician (CT) who receives an initial certificate during a licensing biennium is not required to complete the continuing education requirement from the date of that certificate to the end of that licensing biennium.
